## Rebranding MetLife Auto & Home®

A guide to rebranding assets after the acquisition

## Why:

As part of the acquisition of MetLife Auto & Home business by Farmers Insurance Group<sup>®</sup>, there is a contractual obligation to remove any and all references to MetLife<sup>®</sup>, Met, MetLife Auto & Home<sup>®</sup>, and Metropolitan.

## When:

We must remove from content all references to MetLife, Met, MetLife Auto & Home, and Metropolitan as soon as reasonably practicable, and, in all cases, no later than **October 7, 2021**. We recommend mid-August for the best customer and account experience. The consumer facing rebranding is scheduled to start on August 10, 2021. The following guide was developed to help you transition assets to applicable branding. Your Farmers<sup>®</sup> product specialist and/or MetLife<sup>®</sup> communication manager will work closely with you to help complete this process.
